# EXAMINER CERTIFICATION AGREEMENT

(Effective on Date of Inspector's Certification)

This Agreement is between International Inspector Certification Scheme (hereinafter "IICS") and the Candidate (the "Examiner").

Whereas, IICS Ultrasonic Thickness certifies examiners and other Technical personnel that meet the guidelines and requirements as laid down in the [IICS Requirement Documents – DOCUMENT No. IICS-UTTG-17-07, 1st Edition July 2017](#) .

Whereas, examiners desires to obtain certification under the International Inspector Certification Scheme (IICS).

Now therefore, in consideration of the mutual covenants hereinafter stated, the parties agree as follows:

1. Examiners agrees to comply with all of the program policies and requirements. Examiner agrees and understands that IICS shall be the sole judge of whether the Examiner has the appropriate qualifications to become certified, remain certified, or to be recertified.
2. The Examiner agrees not to make any misrepresentations concerning the Examiner's certification status or the program. The Examiner agrees not to perform any acts, which directly or indirectly assist a third-party in making any misrepresentation relating to the Program.
3. The Examiner understands and agrees that the program is designed to assist users in identifying Examiners who have satisfied the minimum qualifications specified in the applicable industry standards and that **IICS** does not warrant or guarantee the competency of any Examiner certified under this program. The Examiner agrees not to mislead customers or the public about the scope and purpose of this program.
4. The Examiner authorizes **IICS** to release information to regulatory agencies, current or potential employers, or other interested parties concerning the Examiner's certification status. **IICS** agrees to take reasonable measures to ensure that any information that is released is accurate. However, **IICS** does not warrant or guarantee the accuracy of any information that is released and specifically disclaims any liability relating to the release of this data.
5. The Examiner understands and agrees that the Examiner's certification will not be renewed unless the Examiner satisfies all of the program requirements for renewal and submits the appropriate documents and renewal fee to **IICS** within the time frame specified by **IICS**.
6. Examiner understands and agrees that **IICS** may modify the requirements for an Examiner to obtain, maintain, or renew the certification at any time. If **IICS'** requirements are modified, **IICS** shall determine the date by which the new requirements become effective. Examiner agrees to comply with the modified requirements within the deadline specified by **IICS**. **IICS** agrees to attempt (but assumes no duty) to notify Examiner of significant changes to the program by either giving notice: (1) at the Examiner's last known e-mail address, or (2) by posting the changes on the **IICS** website. It is the responsibility of the Examiner to notify **IICS** of address and e-mail changes. The failure of **IICS** to notify Examiner of a renewal date or modification of the program does not relieve the Examiner of the responsibility to file a timely renewal application or to comply with new certification requirements. It is the responsibility of the Examiner to obtain this information by contacting **IICS** or by checking the **IICS** website for updates.
7. Examiner agrees to indemnify **IICS** for any losses or damages resulting from the breach of the terms of this Agreement by the Examiner.

The Examiner agrees and understands that IDC may terminate an Examiner's certification if **IICS** determines that the Examiner has: (1) made material errors, omissions, or misrepresentations on the application or in any other documents submitted to **IICS**, or (2) violated any terms or conditions of this Agreement or program policies or requirements. **IICS** also may terminate the program at any time and for any reason deemed appropriate by **IICS**. Upon termination, with or without cause, of any rights or authority conferred by this Agreement, or upon expiration/termination of the Examiner's certification, Examiner agrees to return all certification documents to **IICS** within 30 days.
9. The Examiner shall not use any trademark of **IICS** or name of IDC including any abbreviation thereof, in any publicity, advertising, or for other promotional purposes without the prior written approval of **IICS**.
10. This agreement shall not and is not intended to benefit or to grant any right or remedy to any person or entity that is not a party to this Agreement.
11. This instrument contains the entire and only agreement between the parties. No oral statements or representations not herein contained shall have any force and effect.
12. Paragraphs 2, 3, 4, 5, 6, 7, and 8 survive termination of this agreement.
13. Examiner agrees not to refer himself as **IICS'** agent nor refer to the relationship between the parties as a joint venture or partnership or in any manner inconsistent with this Agreement. Examiner shall have no authority to act or contract on behalf of **IICS**.
14. **IICS** makes no express or implied warranties regarding the program or potential benefits of the certification to the Examiner.
15. Examiner understands and agrees that Examiner is not granted any rights under the program or this Agreement until **IICS** has determined that the Examiner has satisfied all of the program requirements and has issued a Certificate to the Examiner. The Examiner's certification shall be effective on the date that is noted on the Certificate and shall be effective for a period of three years unless terminated pursuant to the terms of this Agreement.
16. This Agreement shall be governed by and construed in accordance with the laws of the Malaysian Government, without regard to the rules regarding conflicts of law. The parties agree that any action, suit, or proceeding based upon any matter, claim, or controversy arising hereunder or relating hereto shall be brought exclusively in the federal or state courts located in Kuala Lumpur, Malaysia. The parties consent to the jurisdiction and venue of such courts, and waive any objections to the jurisdiction and venue thereof.
